

INVITATION TO BID

The Ethiopian Airports Enterprise (EAE) invites all international competent and qualified consulting firms:-

- For the construction, supervision and contract administration of Addis Ababa Bole International Airport passenger terminal buildings expansion and new VIP salon construction and associated works.
 - Site selection, feasibility study and master plan preparation for the new airport development in the environs' of Addis Ababa.
1. Consultants shall be registered in their country of establishment and should have valid license.
 2. A complete set of Bidding Documents may be purchased by interested eligible bidders upon payment of non-refundable fee of Ethiopian Birr 900.00 (Nine hundred birr only) or USD 50.00 (Fifty) or equivalent amount in freely convertible currency from our Purchasing Team, located at EAE's new head quarter building 2nd floor (in front of the Ethiopian Civil Aviation Authority).
 3. The bidding document can be sent by courier for overseas bidders who send a crossed bank draft of Birr 800.00 or USD 45.00 or an equivalent amount in freely convertible currency in addition to the price of the document mentioned above (2), to the address given below. However, Ethiopian Airports Enterprise will not take any responsibility for a late or non delivery. No extension in bid submission date is permitted in this account.
 4. Sealed bids containing original and copy of technical and financial proposals should be submitted as follows;
 - 4.0 Technical documents- original and copy technical documents should be sealed in separate envelopes and marked "Original Technical Proposal" and "Copy of Technical Proposal".
 - 4.1 Financial documents- original and copy financial documents should be sealed in separate envelopes and marked "Original Financial Proposal" and "Copy of Financial Proposal".
 5. Both the technical and financial documents shall be enclosed in one bigger envelope labeled as Addis Ababa Bole International Airport terminal expansion Project and feasibility study and master planning for new airport development.
 6. All the pages of the bid document shall be sealed and signed by the bidder.
 7. All technical documents should be accompanied by a bid security of Ethiopian Birr 200,000.00 (Two hundred thousand) payable on demand, in the form of CPO or Bank Guarantee (issued by a bank registered in Ethiopia). The bid security shall be sealed in a separate envelope and marked "Bid security".
 8. Each prospective bidder proposing to bid for this project must be eligible fulfilling the requirements of the particular instruction of the project.
 9. Bids should be submitted to: Ethiopian Airports Enterprise, Purchasing Team on or before March 6, 2014 at 10:00 AM. No liability will be accepted for loss or late delivery.
 10. Technical proposals will be opened in the presence of bidders or their representatives who choose to attend, at the EAE new building headquarter conference hall on March 6, 2014 at 10:15AM.
 11. Financial proposals will be opened after the result of the technical proposal analysis is completed.
