

It is efficient in its layout and very user friendly. This extends to TSA personnel who have received their training through a special program in Eugene, Oregon. They are congenial, well informed, and helpful. They facilitate the security process and try to make it as convenient as possible. Coming or going, don't hesitate to ask any one of them a question you may have and they will try to either personally assist or get you to a person who can help.

MAX Train

You can take MAX directly from the PDX Terminal to downtown (MAX station and ticket machines located near baggage claim on lower level of airport - train departs to downtown every 15 min.). Get off at the Pioneer Square North MAX Station on SW 6th & Morrison. It is about two blocks north of the Hilton. Cost from airport: \$2.50; Seniors \$1 (compared to \$40 for taxi), Trip Time: approx. 40 minutes.


