

Michael Dandorph is President, Rush University Medical Center, a \$1.8B enterprise including Rush University Hospital, Rush University Medical Group, Rush University Children's Hospital, Rush Oak Park Hospital and a fully integrated Health Sciences University. Prior to joining Rush in 2013, Mike spent 17 years at the University of Pennsylvania Health System, as SVP, Strategy and Business Development, where he led service line development, managed care, and the expansion of Penn's \$4B clinical enterprise through the development of a 5-hospital system, with over 1500 employed physicians, 7 large ambulatory facilities and a post-acute care network. Prior to his tenure at Penn, Mike

led network development and the regional expansion of First Option Health Plan, a provider-owned HMO headquartered in New Jersey. Mike received his master's in health administration from Cornell's Sloan Program, and his bachelors of science in sports medicine/athletic training from William Paterson University.



Susan Dentzer is the President and Chief Executive Officer of the Network for Excellence in Health Innovation, a not-for-profit organization that seeks intelligent ways to advance health and improve health care at sustainable costs. One of the nation's most respected health and health policy thought leaders and a frequent speaker and commentator on television and radio, including PBS and NPR, Dentzer previously served as senior policy adviser to the Robert Wood Johnson Foundation. She also was formerly editor-in-chief of the policy journal *Health Affairs*, and the on-air Health Correspondent for the *PBS NewsHour*. Dentzer is an elected member of the National Acad-

emy of Medicine (formerly the Institute of Medicine) and also serves on the academy's Board on Population Health and Public Health Practice. She is also a public member of the Board of Directors of the American Board of Medical Specialties, which assists 24 medical specialty boards in the ongoing evaluation and certification of physicians; and is a member of the board of directors of the Public Health Institute, the nonprofit organization addressing public health issues and solutions nationwide.



Dave is the CEO and founder of 4sight Health, a healthcare boutique specializing in thought capital, strategy and venture investing. 4sight Health operates at the intersection of healthcare economics, strategy and capital formation. The company's 4-stage analytic (Assess. Align. Adapt. Advance.) reflects the bottom-up, evolutionary character of market-driven reform. Mr. Johnson is the author of Market vs. Medicine: America's Epic Fight for Better, Affordable Healthcare which published in June 2016. He is the author-in-residence at the Health Management Academy, writes the widely-read "Market Corner" commentaries and contributes monthly to Cain Brothers' Industry Insights. He is

an investor and/or advisor for several early-stage healthcare companies: Bienestar; Curate Health; GaussSoft; HealthiPass; Link Capital and MultiScale. His expertise encompasses health policy, academic medicine, economics, statistics, behavioral finance, disruptive innovation, organizational change and complexity theory. Mr. Johnson holds a Bachelors of Arts degree in English Literature from Colgate University and a Master's degree in Public Policy from Harvard University.

Dr. Kizer is a highly seasoned physician executive whose diverse experience includes senior positions in the public and private sectors, academia and philanthropy. Among his previous positions are: founding CEO and President, National Quality Forum, a quality improvement and consensus standards setting body; Chairman, CEO and President, Medsphere Systems Corporation, a leading commercial provider of open source health information

technology; Under Secretary for Health, U.S. Department of Veterans Affairs and chief executive officer of the nation's largest healthcare system. He is an honors graduate of Stanford University and UCLA, the recipient of two honorary doctorates, and a fellow or distinguished fellow of 11 professional societies. He is board certified in six medical specialties and/or subspecialties, and has authored over 400 original articles, book chapters and other reports.
