This Award Program strives to raise public awareness of the value and design excellence that architects bring to all project types, including renovations and additions, no matter the limits of size and budget.

Recognition

Award winning projects will be recognized in AIA publications and electronic media, including the SPP Journal and website. Projects will also be displayed at the 2013 AIA National Convention and Design Exposition. Select residential award winning projects will be included in *Fine Homebuilding* magazine's annual awards issue, HOUSES, and on finehomebuilding.com.

Judging Criteria

Each entry will be judged for the success with which the project meets its individual program intent and requirements. Entries will be weighed individually, not in competition with one another.

Criteria for judging will include the following:

- The submission complies with all submission requirements
- The project demonstrates exemplary skill in meeting program intent and requirements
- The project achieves excellence in design

2013 Jury

Any project that credits a 2013 jury member or their firm as architect, associate architect, consultant, or client is ineligible and will be disqualified if submitted.

Communication with jurors by entrants is inappropriate and cause for disqualification. All architects of award-winning projects will be required to verify that neither they, nor persons acting on their behalf, had any written or other communication with a juror regarding any submitted project from the time of submittal to completion of the jury process.

Award Categories

There are three built categories and one unbuilt category:

Category 1: A small project construction, object, work of environmental art or architectural design element up to \$150,000.

Category 2: A small project construction, up to \$1,500,000.

Category 3: A small project construction, object, work of environmental art, or architectural design under 5,000 SF constructed by the architect. The architect must have had a significant role in the construction, fabrication and/or installation of the work, in addition to being the designer.

Category 4: Unbuilt architectural designs under 5,000 SF for which there is no current intent to build, of all project types including purely theoretical, visionary projects, with or without a client.

Applicants may enter the same project in more than one category. The entry fee is on a per category basis (e.g. the same project entered in two categories will be charged two entry fees).

The Small Project Practitioners Knowledge Community encourages submissions of projects in all building types: commercial, retail, industrial, educational, public and private, as well as residential. In addition, projects may include fully completed new and renovations or elements of built projects. There is no limitation other than the quality of the final work. We invite the submission of projects accessible to people of all abilities. New construction and renovations are equally welcome.

Finally, the Small Project Practitioners Knowledge Community strongly encourages submissions from the many diverse Small Project Practitioner (SPP) members of the AIA and the profession.

Eligibility

- Open to architects licensed in the United States.
- Built projects completed after January 1, 2009.
- Entry photography by the submitting architect is welcomed, but there is no restriction on professional photography.
- Maximum of four entries per firm – (a single project may be entered in two different categories with applicable fees for each entry). Maximum of two unbuilt entries per firm.
- **No projects are permitted that have previously received a national AIA award.**

Entry Fees

Built Projects (Categories 1, 2 and 3):

AIA members - \$150 for each entry

Nonmembers - \$300 for each entry

Unbuilt Designs (Category 4):

AIA members - \$75 for each entry

Nonmembers - \$150 for each entry

All entry fees are nonrefundable.

Submission Requirements

Images:

- Images include Drawings and Photos.
- Sufficient documentation to describe the project context, special considerations, and innovative design.
- Maximum 8 - minimum 4 images, arranged in the order you wish them viewed.
- Site Plan, Floor Plan(s), Sections and Elevations as appropriate to project type including North arrow and graphic scale.
- Digital parameters: 300 DPI/JPG/High Quality-Low Compression/1600 x 1200 resolution.
- Project authorship may not be revealed in any of the submitted materials.

Text:

- Written information shall be limited to 200 words, including:
- Project name and location (city and state).
- Statement of program and contextual background. In addition, include any special challenges or considerations, unique and/or innovative solutions, lessons learned, or other information pertinent to the understanding of the project.
- Project authorship may not be revealed in any of the submitted materials.

All submitters must agree to the following items:

- All drawings and photographs are products of the design architect.
- Project construction cost (not including soft costs) or square foot area is accurate for the category submitted.
- Project has not received a previous national AIA design award.
- AIA Intern Declaration.
- AIA 2013 Copyright Permission Form

(Note: Project Owners may be contacted to verify information provided.)

Failure to comply with the above requirements will result in disqualification.

Photography Requirements

Image Quality

Photos enable the jury to evaluate your project. An award cannot be made to a project if its relevant details cannot be determined through the submission material. Please follow the submission requirements closely. The digital parameters specified above can be met with a 3-megapixel camera used at its highest resolution and with minimal compression. Use of higher resolution

cameras is acceptable and encouraged.

Image Editing

Images may be edited to improve contrast ratio and color balance. Images may also be cropped, but they may not be edited to alter architectural elements or context. Images identifying authorship must be edited to retain the anonymity of the author. Images may be black and white, sepia or color but may not be colorized black and white images. Images should represent the project, as it exists in the built environment. Artistic composition must not confuse the jury as to the nature of the project.

Any identification of the architect or firm appearing on any submitted images shall cause the entry to be disqualified. Failure to fully comply with all submission requirements shall cause the entry to be disqualified.

Submission Suggestions: Hints for Success

1. Jurors like to see the project context– how it fits into the environment or surroundings, not just a closely cropped view. At least one photo should show the project's relationship to its surroundings.
2. Site plans, floor plans, elevations and sections should be used when appropriate to help describe the project.
3. Jurors often want to see either an unusual approach to a common problem, or a straightforward solution masterfully executed.
4. Professional photography is not required. Photography nonetheless should be of good quality and communicate the project well. Jurors will be reviewing submissions on a computer screen.
5. Presentation is important. Organize your work into a coherent presentation.
6. Use direct, simple language of description. Avoid Archi-talk.
7. Emphasize one or two strong points about the project.
8. Include a single sentence anecdote or description that helps the jury remember your project (i.e. "the church's interior dome was fashioned from an old satellite antenna.")
9. Be sure to emphasize what is unique about your project.
10. Sometimes it might be better to enter a single object from a project, rather than the entire project.
11. You may enter different objects from the same project individually.

Submission Deadline

The submission process must be completed prior to **4:59:59 p.m. Eastern Time, November 12, 2012**. Please allow time for uploading your submission materials - no exceptions to the deadline will be made.

Board Layout

Award recipients are responsible for providing an exhibit panel for display created from their submission materials. A template will be provided for the recipients with instructions for delivery to the AIA in time for convention.
