Introducing the Draft Proposal for the Professional Board of Practice as a means to create excellence in Professional work in the United States of America, as inspired by the excellence of Harvard Architect Charles Bulfinch finishing the United States Capital Building with contractual excellence. This draft proposal is intended to correct the mistakes of NCARB by introducing a formal Professional Board for a documented and official future in the practice of Professional fields. The intended excellence is designed to propagate through incentivized portals, with the primary example being a convoy featuring the American Institute of Architects' Documents in a secure online database of Architectural Practice; additional boards for Law and Medicine are lightly outlined, with the full intention of creating professional excellence in the United States of America.
