The Emerging Professionals (EP) Committee is committed to helping new architects have exposure to the residential architecture industry. We work to help support, advocate for and educate recent graduates and emerging professionals (those licensed less than 10 years) on the opportunities available to them in residential practice.

Who is AIA/CRAN? AIA/CRAN is represented by a 16-member Advisory Group (AG), led by an executive committee that is comprised of a chairman, a past chairperson, a Vice Chairperson, a Second Vice Chairperson and a secretary. Additionally, we have 7 committees and each pursues task-oriented projects that often take the form of a sub-committee.

Optional, but not required include:

- Participate in the AIA National Convention, typically held in May or June.

For continuity and strength within CRAN's leadership, our goal is for committee members to move up to committee leadership positions and potentially serve on the CRAN Advisory Group.
