Commission on Accreditation of Law Enforcement Agencies Chapter 84 Property and Evidence Control

- *Security and Control of seized, recovered, and evidentiary property as well as abandoned, lost, or found property in the custody of the agency.*
- *Maintain Strict measures for the receipt, handling, security, and disposition of property.*
- *Purpose:*
 1. *Support investigations*
 2. *Facilitate timely returns of property*
 3. *Establish agency reputation*

Ex: During an audit associated with (high risk) property an error rate exceeding four percent will require a full inventory of these items. (84.1.6)

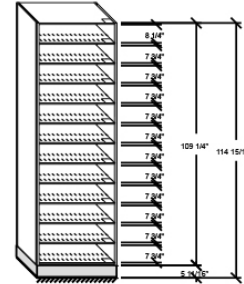




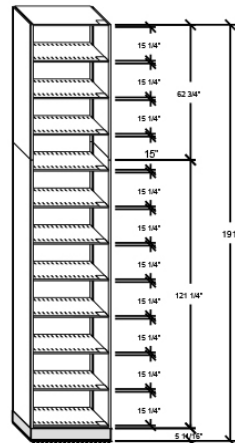
EVIDENCE STAGING SHELVING ELEVATION
30" WIDE X 18" DEEP PER SIDE



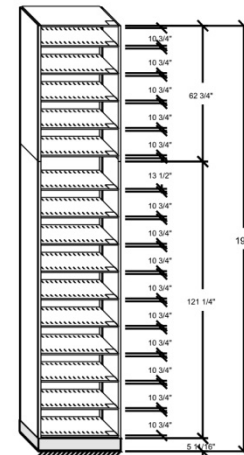
MOBILE HANDGUN STORAGE SHELVING ELEVATION
30"-36" WIDE X 10" DEEP PER SIDE



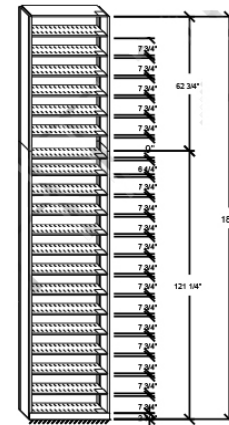
LARGE TOTE STORAGE SHELVING ELEVATION

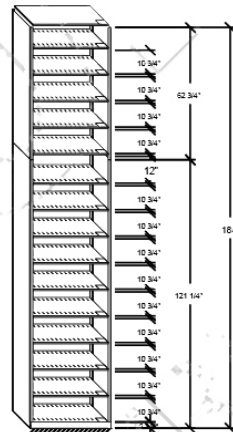

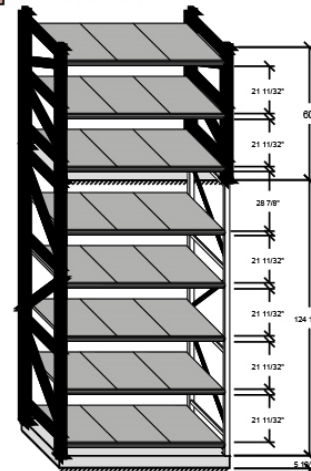

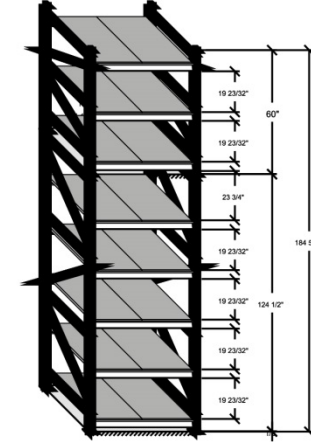

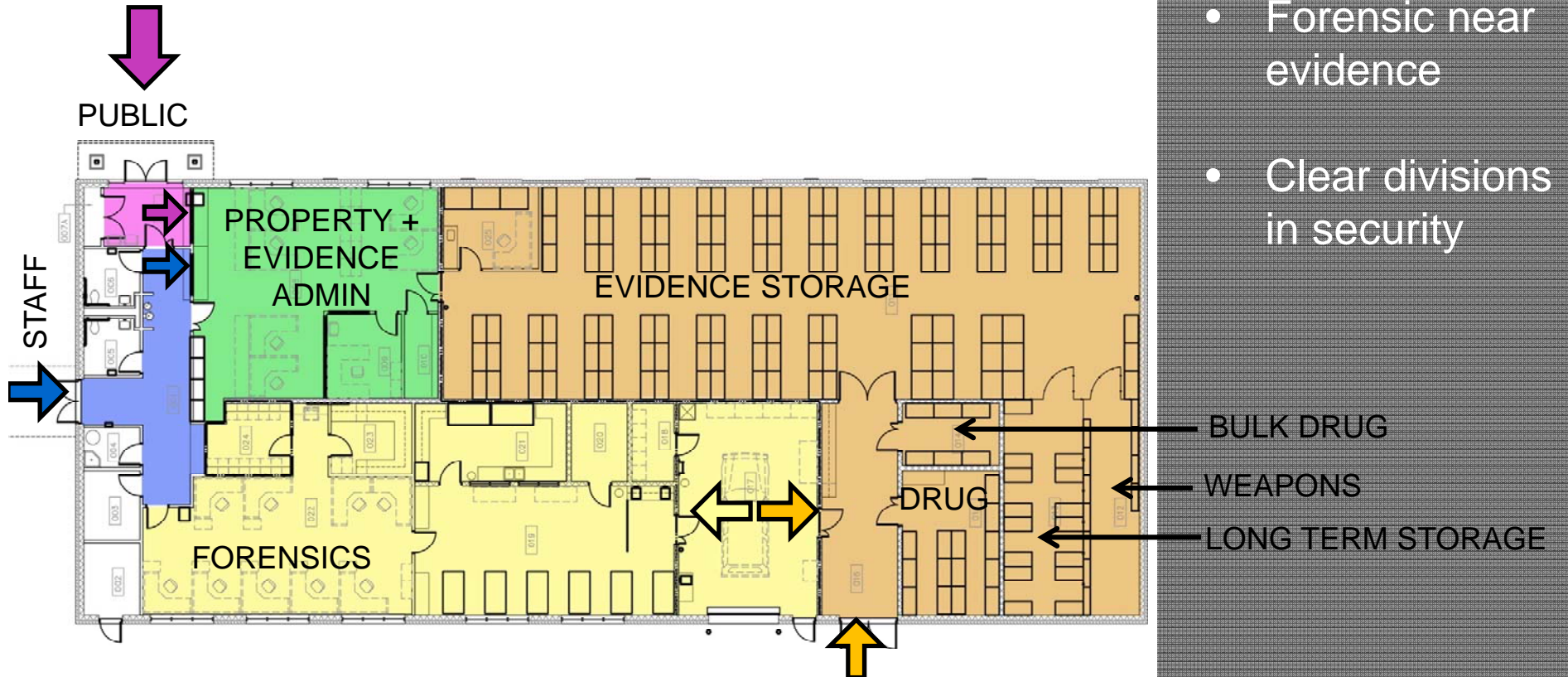
Exterior

ARCHITECT PERSPECTIVE

1. Separate and New building is preferred.
 - Cheaper building type
 - Removes threat and risk to Main Police Station
 - Located near Forensics Lab
 - Design with Chain of Custody in Mind
2. Design for flexibility
 - Expansion
 - Long term goals.
3. Operational Management
4. Avoid water above evidence. (Multi-story)

EVIDENCE TRENDS

1. Off-Site Evidence Storage Warehouses
2. Regionalization of Small Departments
3. Body Camera Data
4. Digital Evidence
5. Marijuana Legalized
6. High Hazard Drugs
7. Statue of limitation: On Going Purge.
