My own "a-ha" moment came when my firm calculated all the embodied carbon emitted from building the Portola Valley Town Center. It's a very efficient project and performed better than expected, but when we ran all the numbers we found that construction still emitted 1,000 tons of carbon—roughly the same as 10 years of operating emissions. The good news is there are several steps architects can take to make significant upfront impacts in the design and construction process. Read more >
