Dr. Paul Biddinger is the Director of the Center for Disaster Medicine, and is Vice Chairman for Emergency Preparedness in the Department of Emergency Medicine at Massachusetts General Hospital (MGH) in Boston. He is an active researcher in the field of emergency preparedness and has lectured nationally and internationally on topics of preparedness and disaster medicine. Dr. Biddinger completed his undergraduate study in international relations at Princeton University, attended medical school at Vanderbilt University, and completed residency training in emergency medicine at Harvard.



Since 2013, **Akram Boutros** has piloted an unprecedented transformation of Cuyahoga County's public health care system.
