

About the AIA International Practice Committee

The International Practice Committee is a group of architects and allied professionals involved and/or interested in international practice. The International Practice Committee Advisory Group explores and monitors global practice and policy issues to be addressed by the President, the Executive Committee, and the Board of Directors. The committee focuses on facilitating members' practice in global markets, identifying and developing practice resources, and providing an active network of architects engaged in international practice. The committee serves all members by engaging in the global architecture community to advance the highest international standards of education, training, and practice.

The committee's current form (although not always with the same name) began to take shape in the early 1990s; however, the Institute has a history of committees or programs for international relations dating back to 1891. Over the past two decades, the committee has been continually developing in terms of its members and scope. In many ways this committee echoes the development of global practice for the Institute's members, specifically the ever increasing number of members practicing abroad and the new challenges and opportunities of practice internationally. The committee at one time included a liaison to the Architects' Council of Europe (ACE) and an NCARB representative, and currently includes representatives to the International Union of Architects (UIA) and the Pan-American Federation of Associations of Architects (FPAA). Since the 1990s, the International Committee Advisory Group was an advisory committee of largely US based members who were involved in practice internationally. Around 2009, the presidents and leadership of the overseas components joined the committee as ex-officio members; the ICAG became a forum for the overseas components and members to have a voice at the AIA National level. The committee has various tasks and duties that it performs such as recommending Honorary Fellow jurors, developing practice tools and knowledge, advising the AIA President and Executive Committee on international issues, etc. Now that the AIA International Region has been formed, the Institute looks to this committee to refocus on international practice and practice issues; meanwhile, the IR is best suited to support the overseas components on structural, governance and membership issues.

From the 1860s until 1888, the AIA elected an officer to handle correspondence with architectural societies and architects in foreign countries. The office was initially called Corresponding Secretary, then changed in 1870 to Secretary for Foreign Correspondence. The position was not included in the new bylaws that were developed for the merger between the AIA and the Western Association of Architects in 1889.

The Advocacy Center helps to ensure that sales of U.S. products and services have the best possible chance competing abroad. Advocacy assistance is wide and varied but often involves companies that want the U.S. Government to communicate a message to foreign governments or government-owned corporations on behalf of their commercial interest, typically in a competitive bid contest. Since its creation in 1993, the Advocacy Center has helped hundreds of U.S. companies — small, medium and large enterprises in various industry sectors — to win government contracts across the globe. In short, we are your advocates! In pursuing foreign business opportunities, we encourage you and your company to contact us early and often.

The Advocacy Center also has Commercial Service liaisons to five Multilateral Development Banks (World Bank, Inter-American Development Bank, European Bank for Reconstruction and Development, African Development Bank and Asian Development Bank) to assist U.S. firms and advocate on their behalf when they compete for Bank tenders. The liaisons counsel U.S. companies on how to work with the Banks and advocate on procurement and contracting issues to ensure fair and equal treatment for U.S. companies.

The World Bank lends and invests billions of dollars in developing countries every year. This constant stream of funds is used to buy goods, consulting services, and civil works projects that contribute to economic development in those countries. The system of doing business with the World Bank is similar to government procurement systems in many countries.

The Advocacy Center Commercial Liaison Office to the Inter-American Development Bank (IDB) is an integral part of the United States Executive Director's Office to the Bank. The Commercial Liaison Office's mission is to help American businesses take advantage of commercial opportunities through the IDB's numerous projects. Established in 1959 and with more than \$100 billion in capital, the IDB is the oldest and largest regional development bank. Its primary goal is to help accelerate economic growth and social development in Latin America and the Caribbean. The IDB has 48 member countries: 26 borrowing members and 22 non-borrowing members, including the United States, its largest stakeholder. The region's primary source of multilateral financing, the IDB provides loans, guarantees, and technical assistance for public- and private sector projects and generates tens of thousands of contracts every year, ranging in size from a few thousand to hundreds of millions of dollars. These represent numerous commercial possibilities for businesses, including small and medium-sized enterprises, in public works, supply of goods, and consulting services.

The IDB Group is composed of the Inter-American Development Bank, the Inter-American Investment Corporation (IIC) and the Multilateral Investment Fund (MIF). The IIC focuses on support for small and medium-sized businesses, while the MIF promotes private sector growth through grants and investments, with an emphasis on microenterprise.
