Course Description

Historically, counties have been hard pressed to keep pace with growing jail populations and costs. Public sentiment and justice initiatives aimed at reducing jail bedspace are changing that – many county jails are now below design capacity. With the "pressure off", officials are asking a different question:

"How can we effectively plan for a NO growth scenario?"

This case study presents two counties who are redeveloping their correctional facilities to respond to address this challenge. In **Travis County, TX** the plan includes replacement of outmoded buildings on the correctional complex to address special housing needs and programmatic objectives without significantly increasing bedspace capacity.

The **Dutchess County, NY** plan includes a Justice and Transition Center that provides intensive reentry programming for inmates. Located downtown, the Center will improve the urban fabric immediately around the jail as the cornerstone of a larger urban development initiative.

The declining demand for bedspace provides officials and administrators with challenges and opportunities. The justice architect and planner can assist the client in developing long range development plans that go beyond the traditional focus of expanded capacity.

- Jail Construction boom mid 1980's and beyond

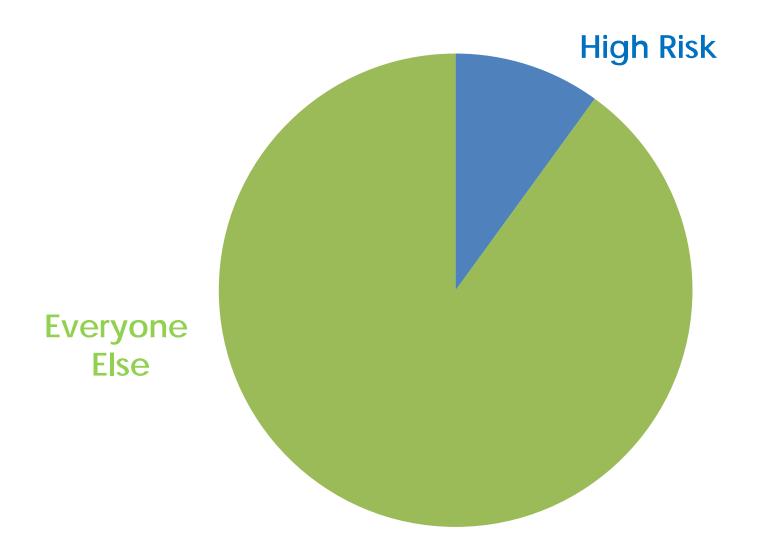

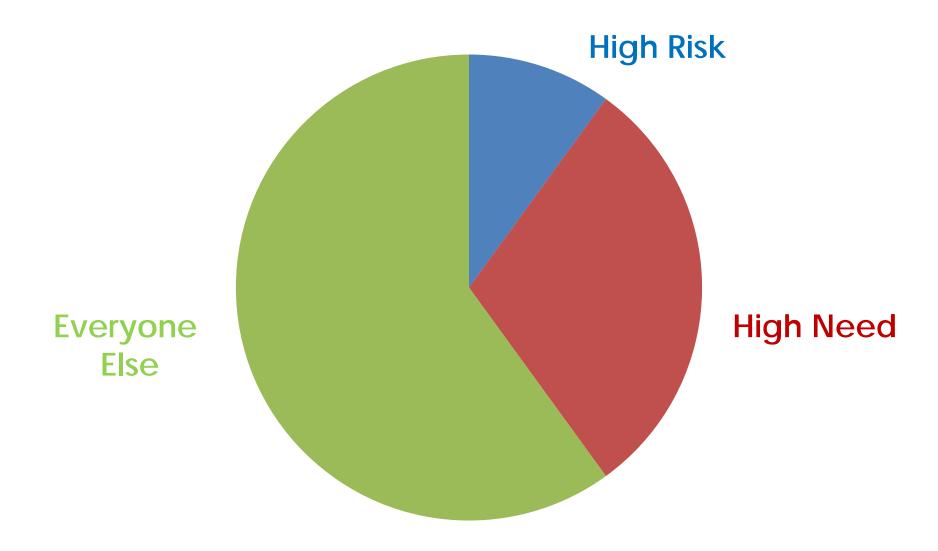

TWO CASE STUDIES

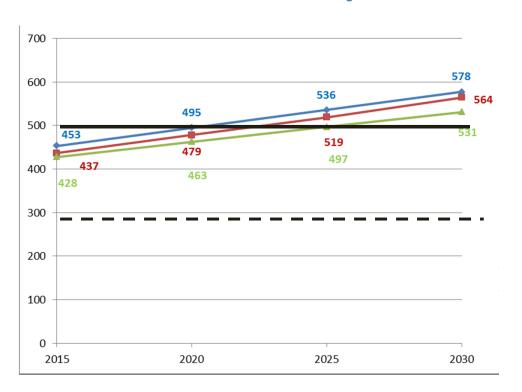
- Dutchess County NY; Travis County, TX
- Jail capacity expanded 10-20 years ago
- Flat to moderate inmate population projections
- Changes in inmate population profiles
- Challenging correctional facilities/conditions
- Limited program/rehab opportunities
- Proactive approach to shaping the future

DUTCHESS COUNTY: KEY ISSUES

- Insufficient capacity 200 inmates boarded out
- Focus on reentry to break the cycle of recidivism
- More effective design for high need inmates
- Create a campus feel on a downtown site
- Phased approach to expanding in place

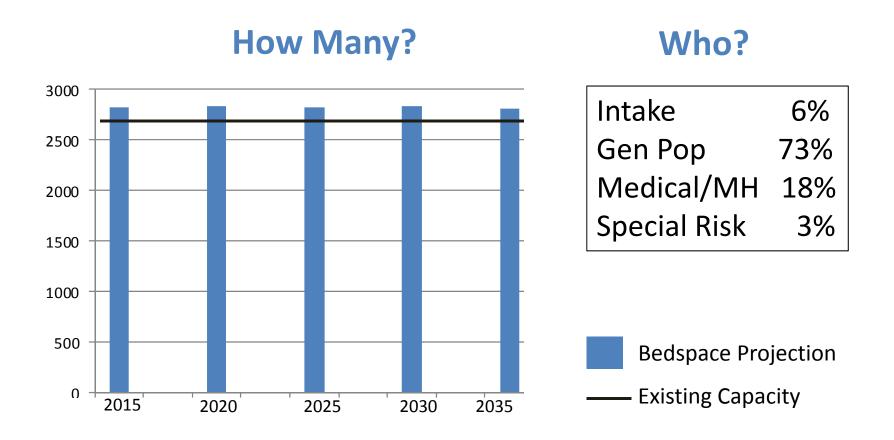

- Inefficient operations

- Long term campus development

NEEDS ASSESSMENT and VALIDATION STUDY

Criminal Justice Council (CJC) Needs Assessment Report – Nov 2012

- Alternatives to Incarceration (ATIs) divert approx. 600 of approx. 1100 individuals daily
- Existing 1984/1995 Jail, with classification requirements can house approx. 260 of approx. 500 inmates = 200+ housed out
- Recommendations
 - •Continue CJC efforts
 - Build a better jail

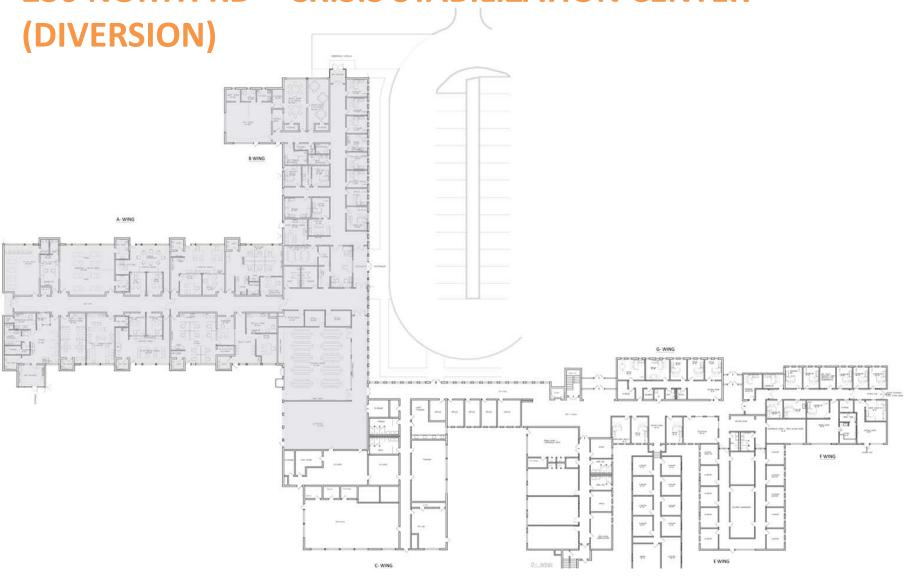

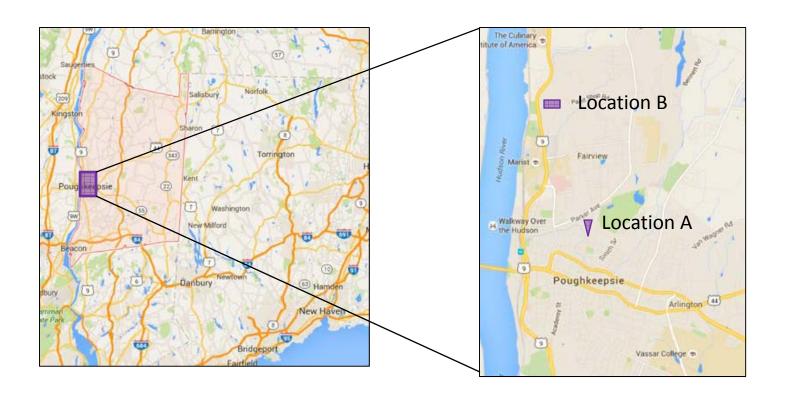

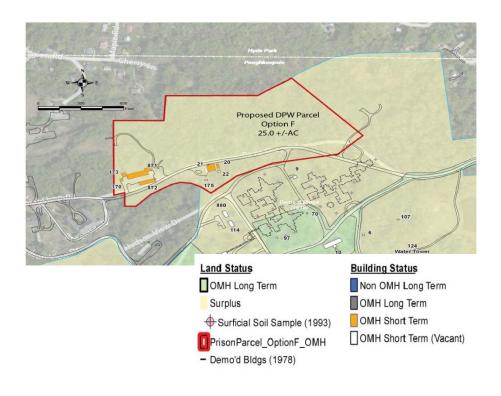

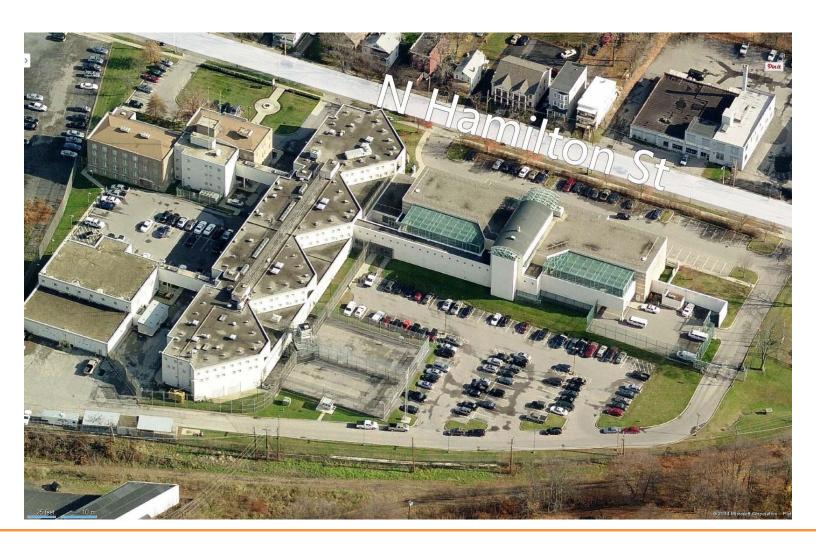

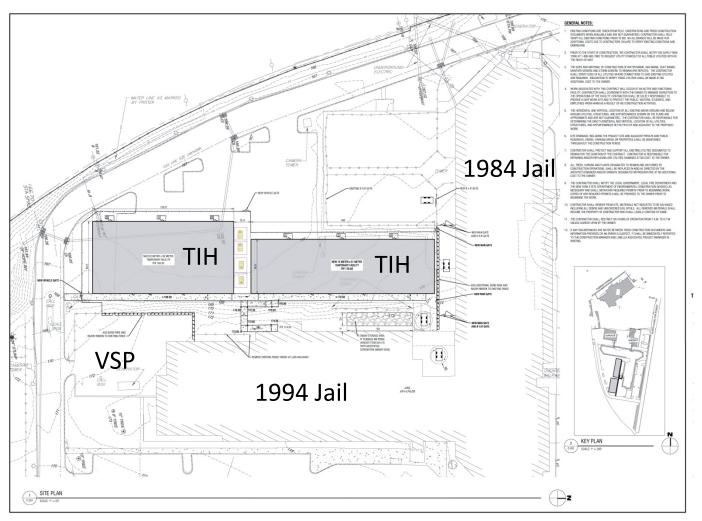

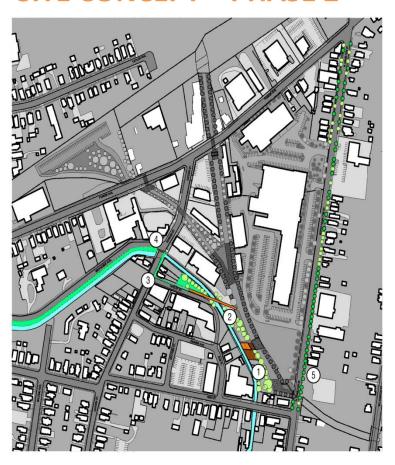

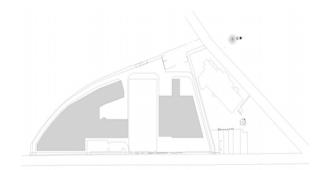

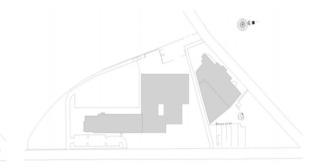

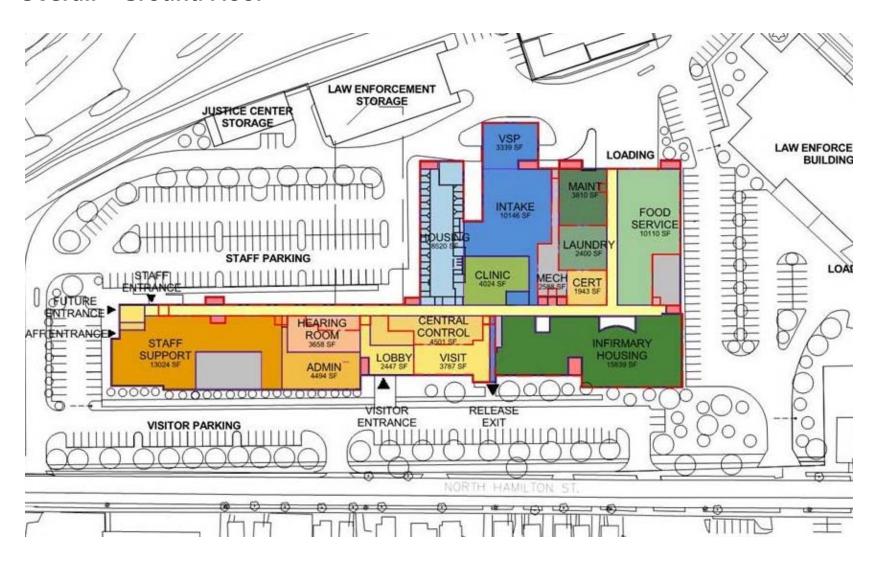

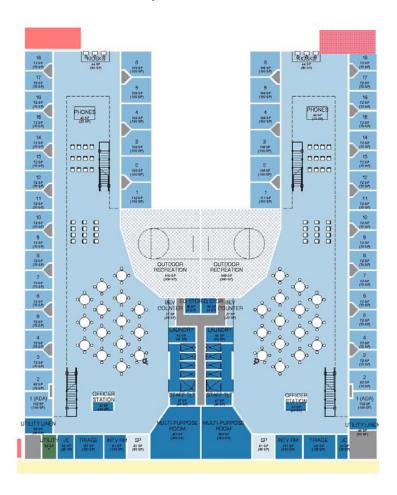

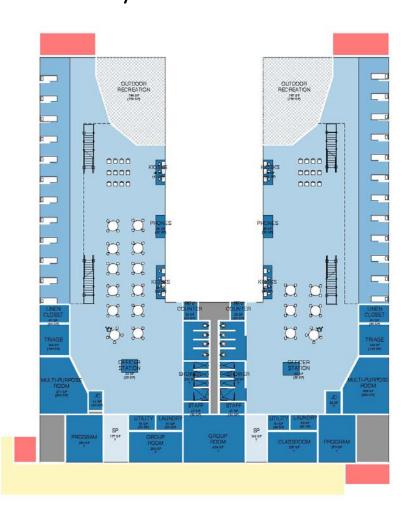

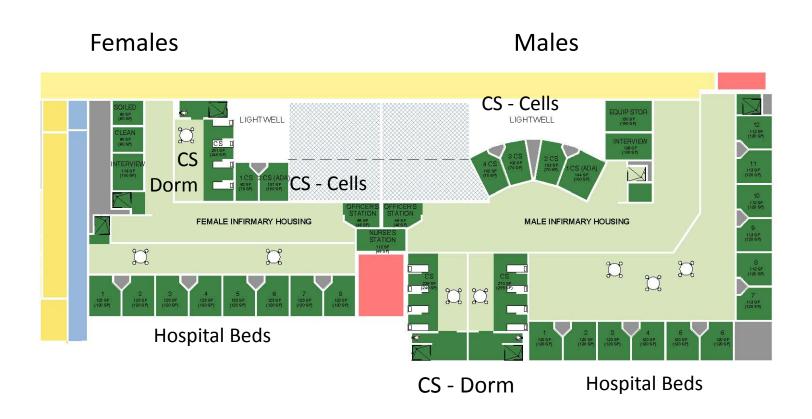

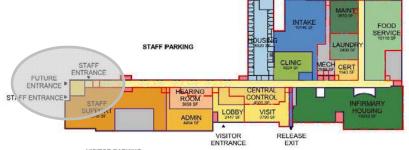

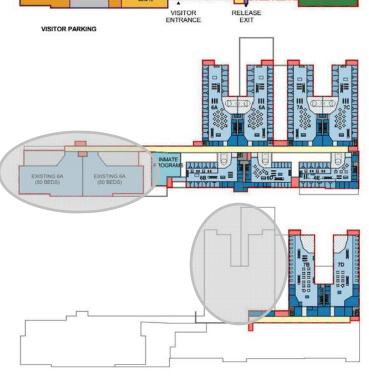

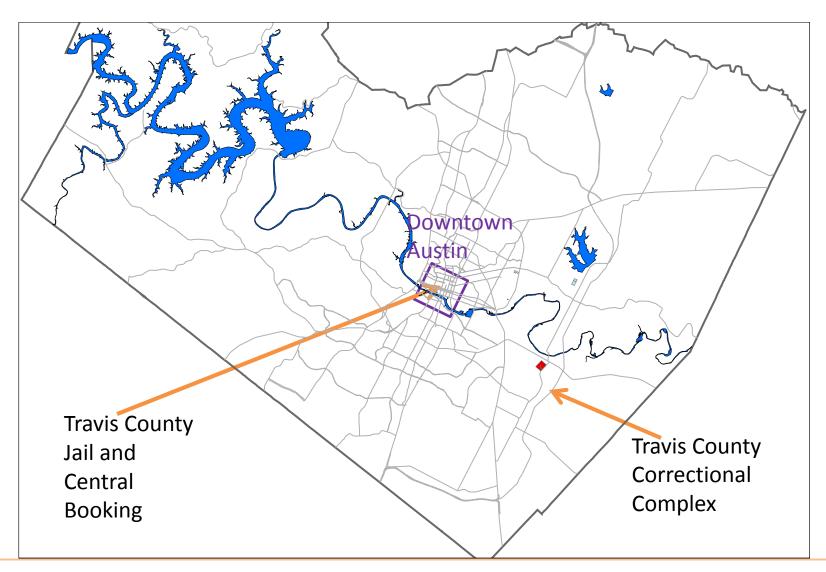
CHALLENGES

- Positive perspectives for justice and overall project

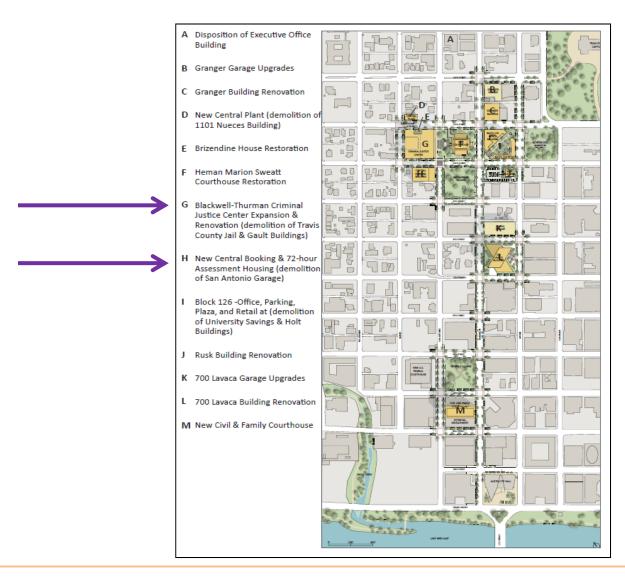
Travis County, Texas Correctional Needs Assessment and Master Plan

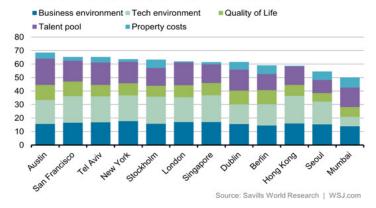

CORRECTIONAL SYSTEM NEEDS ASSESSMENT

BUT:

- Bed space mismatches
- Changing jail population and human needs
- Aging facilities
- Shifting space from downtown to the Correctional Complex

NEEDS ASSESSMENT RECOMMENDATIONS

- Provide a long-term housing plan for about 2,834 beds.
- Provide adequate housing for special populations:
 - Females
 - Medical/Mental Health
 - Youthful Offenders
- Where possible, house maximum and medium security inmates separately.
- Enhance on-site medical specialty clinics.
- Expand inmate programs and vocational training opportunities.
- Consider an on-site courtroom or video capability at TCCC.

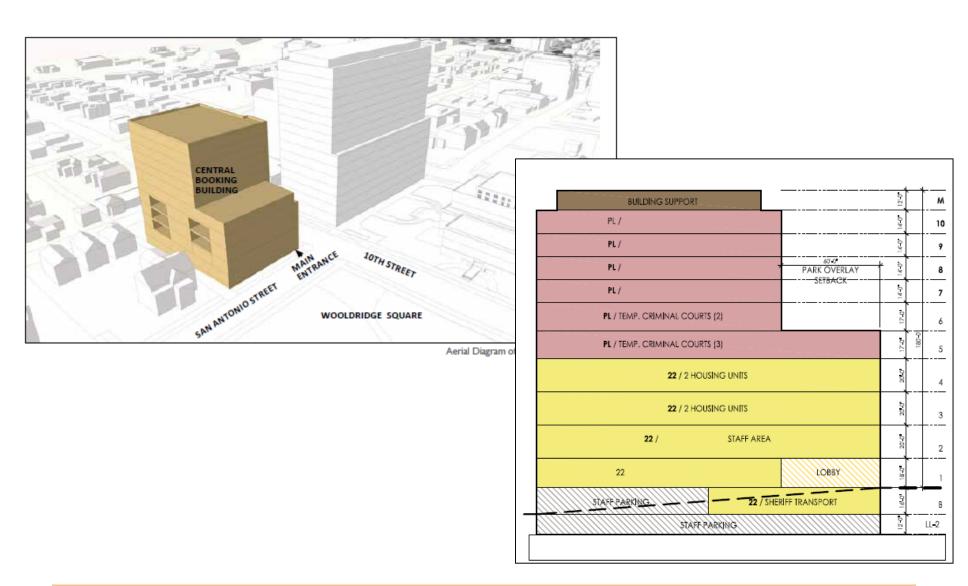

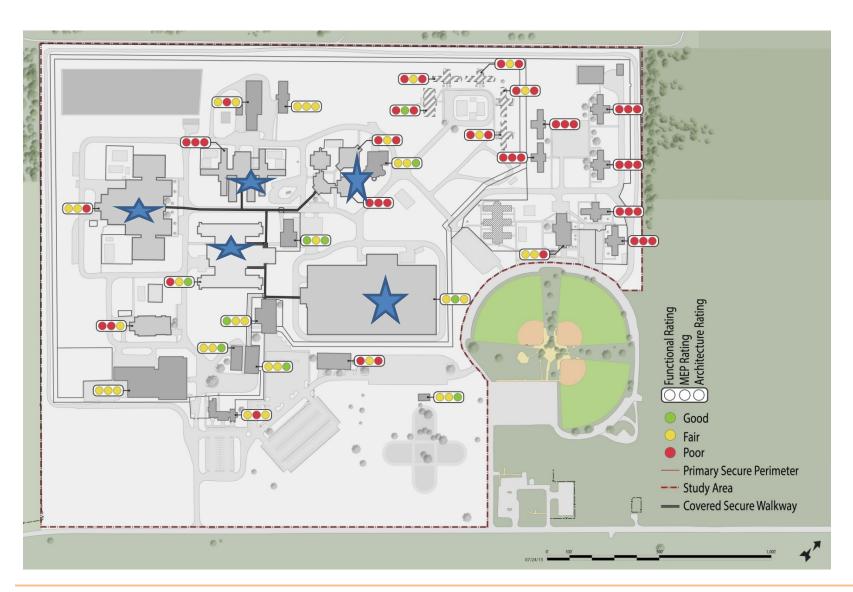

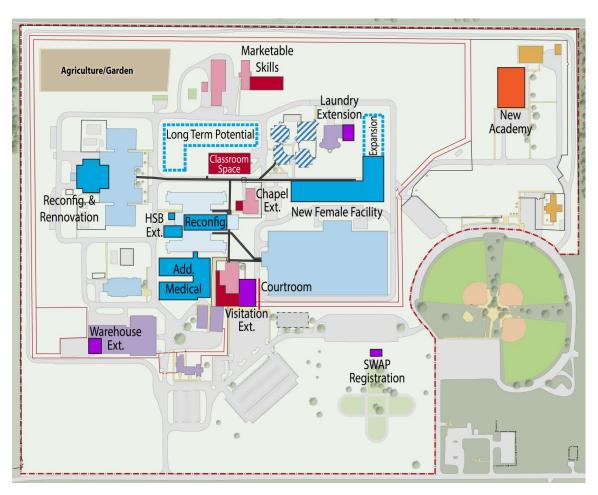

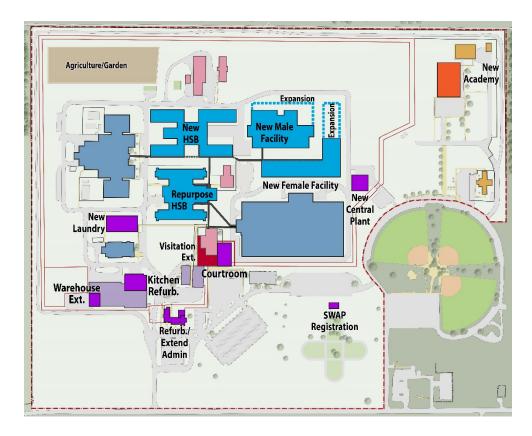

New Male Building- 304 beds:

240 GENERAL POPULATION MALE

Relocated from building 1

- **144** medium security beds
- **96** maximum beds
- 64 HIGH RISK POPULATION Beds

AdSeg, Lockdown, PC, etc. Relocated from building 1

CONCLUSIONS

- There is a data lag in the planning process
- Master Plans must be living documents
- Slow growth does not mean no change needed
- Efficiency can be found through new construction and realignment

WRAP UP

- Use times of slow growth for purposeful planning
- Address critical needs first as part of an integrated long term plan
- Realign, repurpose, or retire existing assets
- Revisit the plan before each phase
- Multiple stakeholders = participatory process
