#### Who is AIA Massachusetts?

For more than 150 years, the members of the American Institute of Architects (AIA) have worked to advance our quality of life through design. From designing the next generation of energy-saving buildings to making our communities healthier and more vibrant, from helping neighborhoods rebuild after disasters to exporting American design know-how to the rest of the world, architects turn dreams and aspirations into reality. Decisions are being made every day that affect the way architects practice by federal, state, and local lawmakers, and AIA aims to serve its members as the voice of the profession to the decision-makers at all levels of government.

Nationally, AIA represents more than 90,000 members who are part of an employment base of more than 200,000 U.S. jobs. The AIA represents this extensive constituency on a range of issues, including livable

# Some Regulatory Work

AIA MA has been asked to participate on a number of state commissions/task forces. The subject matter of each commission/task force varies, but each commission /task force is tasked with solving a particular problem related to the built environment. The state has asked AIA Massachusetts to serve on the following commissions/task forces:

# 1. Commonwealth Facilities Advisory Council

**Purpose:** Chapter 165 of the A/R of 2012 required the long-term strategy to improve the efficiency and effectiveness of the Commonwealth's approach to facility management and maintenance is to fully consolidate management and maintenance functions for as many state facilities as appropriate under a single entity.

#### 2. Commonwealth of Massachusetts Accelerated Energy Program

**Purpose:** The Accelerated Energy Program (AEP) was established in December 2011 to accelerate the implementation of energy and water projects across the Commonwealth and help the Commonwealth comply with Executive Order 484, Clean Energy and Efficient Buildings, signed by Governor Patrick in April 2007. The Division of Capital Asset Management and Maintenance (DCAMM) is working with the Department of Energy Resources (DOER) and other partners to retrofit 700 sites encompassing more than 4,800 buildings throughout the Commonwealth in 700 days.

#### 3. Commonwealth Construction Law Working Group

**Purpose:** Building on the Construction Reform Laws of 2004 the Construction Law Working Group of 2011 has the following shared goals: improve efficiency of administrative processes for entry into public construction; improve exclusion of "bad actors" from public construction projects; increase access and opportunities for small, minority, and women-owned businesses\workers; and tighten the gap between contract (bid) amounts and actual costs of public projects.

#### 4. MSBA/AIA Working Group to discuss Newtown shooting

**Purpose:** In April 2013 AIA MA was contacted by Matt Donovan, Chief Operating Officer of MSBA. MSBA was interested in convening a small group discussion on the topic of the Newtown shooting. The question was what, if any, response should MSBA have to this issue. The Working Group discussions have now merged with the

Governors Executive Order 548 which established a cross-secretariat task force on school safety and security

### 5. Boston Survivors Accessibility Alliance

**Purpose:** DPS has established the Boston Survivors Accessibility Alliance (BSAA) to assist those who may need assistance with renovations to help transition to a new lifestyle. The focus of these services is on home modifications; however, consideration may be given to modifications to businesses owned by the individual. Modifications may include construction of ramps, widening doorways to accommodate wheelchairs, reconfiguring bathroom or kitchen space or other appropriate renovations. The group will focus on assisting individuals in obtaining suitable design and construction services, sorting through permitting and approvals processes, and general guidance through what may otherwise be a daunting task. All services will be donated and all fees waived.

#### 6. Blended Building Code

**Purpose:** Work with the Building Board of Regulations and Standards (BBRS) to ensure that instead of the current practice of taking the ICC's base building code and adding Massachusetts "front-end" amendments to it, AIA MA will work to ensure that the upcoming 9th edition of the state building code is "blended", meaning that all MA amendments are "blended" into ICC's base IBC/IRC language.

# 7. AIA MA/ACEC/DCAM Working Group

**Purpose:** DCAM needs a place to interface with the AE community, break down barriers and be honest with each other. DCAM needs to review policy and procedures that have been in place for a long time, and see what can be improved. Designers can be helpful in shaping this future direction. Items for discussion within the group include: BIM; LEAN for construction; integrated project delivery; design excellence; ADA and MAAB; construction administration and design fees; MBE\WBE goals and changes; CM process; study and design work plans; 179D tax deduction; and house doctor selection process.
