She was inducted into the State of Florida and City of Miami Women's Hall of Fame. She held a presidential appointment to the Federal Advisory Council on Historic Preservation and chaired the Florida Humanities Council and the Southern Region Board of Advisors of the National Trust for Historic Preservation. Recently, both the Florida Historical Society and the Florida Trust for Historic Preservation presented her with their highest honor.
